Additions and Deletions to the Agenda: Additions to the agenda are limited by California Government Code Section 54954.2 and confined to items that arise after the posting of the Agenda and must be acted upon prior to the next Strategic Planning Committee meeting. For special meeting agendas, only those items listed on the published agenda may be discussed. The items on the agenda are arranged in three categories. <u>Consent</u> <u>Calendar</u>: These are relatively minor in nature, do not have any outstanding issues or concerns, and do not require a public hearing. All consent calendar items are considered by the Committee as one item and a single vote is taken for their approval, unless an item is pulled from the consent calendar for individual discussion. There is no public discussion of consent calendar items unless requested by the Committee.

**Public Hearings:** This category is for matters that require, by law, a hearing open to public comment because of the particular nature of the request. Public hearings are formally conducted and public input/testimony is requested at a specific time. This is your opportunity to speak on the item(s) that concern you. If, in the future, you wish to challenge in court any of the matters on this agenda for which a public hearing is to be conducted, you may be limited to raising only those issues which you (or someone else) raised orally at the public hearing or in written correspondence received by the Committee at or before the hearing. **Committee Business**: Items in this category are general in nature and may require Committee action. Public input will be received on each item of Committee Business.

**Public Input:** If you are interested in addressing the Committee, you may submit comments on any agenda item or on any item not on the agenda, in writing via mail to "Attn: Alliance Strategic Planning Committee," 1240 S. Loop Road, Alameda, CA 94502; or through e-comment at <u>brmartinez@alamedaalliance.org</u>. <u>You may also</u> provide comments during the meeting at the end of each topic.

## **CAC OVERVIEW**

Alliance For Health

- ▷ What is the CAC?
  - **Provides a Link Between the Alliance and Members:** CAC serves as a bridge between the Alliance and the community.
  - Services as an Advisory Role: CAC members provide advice to the Alliance on cultural and linguistic services, health care programs, and policy concerns.
  - Member Representation: CAC offers the Alliance a member's perspective on the needs and concerns of special groups, including:
    - → Older adults
    - Persons with disabilities
    - → Families with children
    - → People who speak a primary language other than English.
  - CAC reports directly to the Board of Governors (BOG).

# **CAC SELECTION COMMITTEE**

Alliance For HEALTH

- **Background:** 
  - 2024 DHCS Medi-Cal Contract: Alliance must create a CAC Selection Committee that will select members of the CAC.
  - The CAC SC reports to the Alliance BOG.
- **SC** Membership:
  - Term of Service: **2 years** with possible reappointment by the Alliance BOG.
  - Representation:
    - → Persons on the Alliance's Governing Board, including:
      - Safety Net Providers including FQHCs Dental Providers
      - Behavioral Health Providers
      - Regional Centers (RC)
      - Local Education Agencies (LEAs)

- Indian Health Care Providers
- Home and Community-Based Service (HCBS) program Providers
- → Persons and community-based organizations within the Alliance's Service Area.

## **CAC SELECTION COMMITTEE**

#### Alliance FOR HEALTH

### **SC Meetings:**

- Meet on an as-needed basis.
- Follow Brown Act Requirements.
  - → SC meeting agenda and packet shall be posted on Alliance website at least 72 hours prior to meeting
- Voting and Attendance:
  - → Votes require a quorum.
  - Virtual attendance needs approval.
- ▷ Officers of SC:
  - Chair: BOG Chair
  - Vice Chair: BOG Vice Chair

# **CAC SC Roles and Responsibilities**



## **CAC SELECTION COMMITTEE**

Alliance For Health

- ▷ SC Responsibilities include:
  - Selecting members of the CAC and presenting to Alliance BOG for final review/approval.
  - Ensuring CAC membership reflects the Medi-Cal Member population in Alameda County, including diverse representatives.
  - Modifying the CAC to ensure community representation and engagement.
  - Including representatives from diverse and hard-to-reach populations, focusing on health disparities and diversity in race, ethnicity, gender identity, sexual orientation, and physical disabilities.
  - **Replacing vacant CAC** seats within **60 days** when a member resigns or is unable to serve.















CAC Candidate Recruitment Create CAC Candidate Summaries Activities:

- Call for a CAC SC meeting.
- Present summary of applicants to CAC SC.
- CAC SC votes to approve candidates.

Present CAC Member Interests to CAC SC for Review/Vote Present CAC Candidates to Alliance BOG for Review/Approval

Activities:

- SC Chair presents list of approved CAC candidates to BOG.
- BOG votes to approve.
